- ♦ **3rd ISC Public Review of Standard 23P, *Methods for Performance Testing Positive Displacement Refrigerant Compressors and Compressor Units***

ASHRAE Standard 23-202x prescribes methods for performance testing positive displacement refrigerant compressors and compressor units, including capacity, isentropic efficiency, and volumetric efficiency. This third Independent Substantive Change Publication Public Review draft adds a new Section 5.8 and renumbers the previous Section 5.8 and subsequent sections. Section 10 has also been updated.

CALL FOR PARTICIPATION IN AHRI STANDARDS ACTIVITIES

AHRI's Standards team is seeking volunteers to participate in the review and final approval of AHRI standards to be published as an American National Standard (ANS) or National Standard of Canada (NSC). This final approval is the responsibility of a group called a Consensus Body. AHRI needs experts in the field of HVACR to serve as members of the Consensus Body.

As required by the American National Standards Institute (ANSI), membership in a Consensus Body must represent a balance of interests, so AHRI is going outside of its manufacturer-centered membership to include persons representing other interests. AHRI membership is not required for participation.
